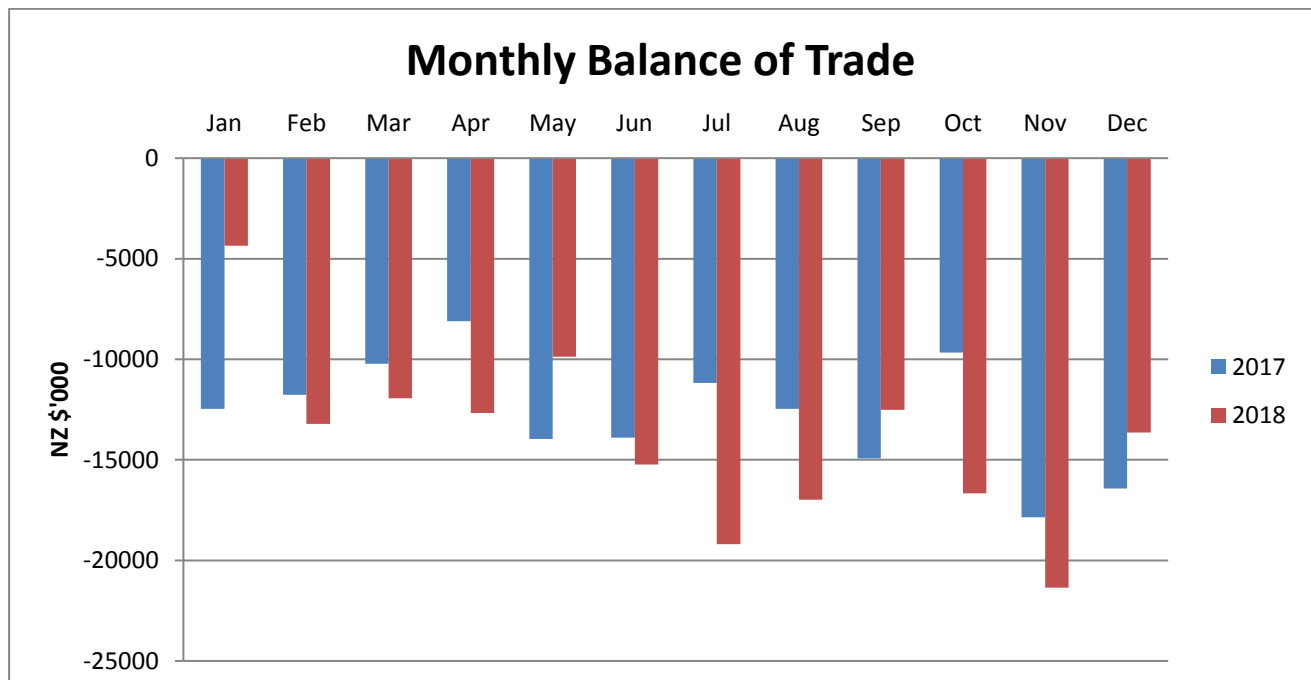
OVERSEAS TRADE STATISTICS
December 2018

Balance of Trade – The balance of trade for the month of December 2018 showed a deficit of \$13.6 million, when compared to the same month over the previous year this showed a decrease of \$2.7 million, likewise a \$7.7 million decrease compared to November 2018.

Exports – Total exports for the month of December 2018 was \$0.74 million, decreasing by \$0.3million when compared to December 2017 and by \$0.73 million when compared to November 2018. Fresh or chilled fish dominates the export market as our prime export commodity out of the Cook Islands making up 73.3 per cent of the total exports.

Imports – Total imports for the month of December 2018 was \$14.3 million, made up predominantly of Machine, transport and equipment's (\$3.3 million) and Food items (\$2.9 million). The majority of our imports, 63.7 per cent come from New Zealand.

Taxes Generated from Imports - Total revenue generated from imports for the month of December was \$3.7 million of which \$2.3 million was from value added tax and, the remaining \$1.4 million from import duties.
