‘Akako‘u‘anga - Overview

Kua akaari mai te ‘akamārama‘anga o te kimi pū‘apinga e ko te “akaputu‘anga “apinga ‘anga‘anga a te kavamani i te tuātau i topa ei te tūranga kimi pū‘apinga ki raro ka riro te reira ei vāitoanga meitaki no te ‘akaiti i te ‘akatūkia o te tūkaui ki runga i te tu‘anga kimi pū‘apinga. E kimi‘anga rāvenga teia e tā‘anga‘anga‘ia ana e te Kavamani e pini uake teia nei ao, mei ia Aotearo‘a e te Kavamani Autireria e ‘akaputu nei, ara atu i te tai pirioni tārā ki roto i te ‘akaputu‘anga ‘apinga ‘anga‘anga no te ‘akapō‘itirere‘anga a te Kōviti 19.

I roto i te mataitai 2021 kua tuku mai te Kavamani Kūki ‘Airani i tētai ‘akakite‘anga no te Parāni ‘akaputu‘anga “apinga a te ipukarea(NIIP). Ka aka‘ōu ua rai te NIIP i te ‘akakoro‘anga tumu ki roto i te “akaputu‘anga “apinga ‘anga‘anga a te Kavamani e ka ‘akakite mai i te au ‘anga‘anga mama‘ata te ‘inangaro‘ia kia raveia i roto i te nga‘uru mata‘iti, mate ‘ōronga mai i tētā‘i ‘akapapa‘anga o te au ‘anga‘anga mama‘ata e te au ‘apinga ‘anga‘anga te ka anoanoia.

Ko te i‘oanga i te meitaki o te kimi pū‘apinga i roto i te tuātau poto e te tūpoto, ka ‘ātui‘ia te reira ki teia au ‘anga‘anga mama‘ata ei ‘akakite‘anga e ko tē‘ea te ka ‘ōronga viviki mai i te meitaki na roto i te ngai ‘anga‘anga na te iti tangata Kūki ‘Airani, me kare i te apai mai i te aronga ‘anga‘anga mei vao mai i te akama‘ata atu i te nūmero tangata i roto nei i te Kūki ‘Airani na roto i te meitaki o te tuātau tūpoto e te au tu‘anga ‘anga‘anga kimi pū‘apinga.

Ko te tūtaki‘anga o teia au ‘anga‘anga mama‘ata no roto mai te reira i te vairanga moni a te Kavamani Kuki Airani e pērā te moni ‘anga‘anga ka piri katoa mai te moni kaio‘u, me kare te au pātana tauturu e pera te Moni ‘apinga ‘anga‘anga kapiti a Aotearo‘a e te Kūki ‘Airani.

Te Ata - Context

Ka ‘akatupu te “akaputu‘anga “apinga ‘anga‘anga i te meitaki tūpoto na roto i te ‘akama‘ata‘anga i tē ka rauka mai no roto i te tu‘anga kimi pū‘apinga na roto i te mā‘ani‘anga i te au ‘apinga ‘anga‘anga ei tu‘anga ki roto i te tu‘anga kimi pū‘apinga mei te au pītiniti kāre i raro ake i te ‘akatere‘anga a te Kavamani e te au tangata tātākita‘i e oronga ana i te ropianga tuketuke tei riro ei tā‘anga‘anga i te iti tangata. I te reira ‘ati‘anga katoa ko te mā‘ani‘anga o te au ‘apinga ‘anga‘anga ka anoanoia te aronga ‘anga‘anga tuātau poto no te akatū i te reira. E no te reira ka akatupu te ‘akaputu‘anga ‘apinga ‘anga‘anga i te ngai ‘anga‘anga tuātau poto e pērā katoa i te akama‘ata i te aronga angaanga tuātau tūpoto. Mei te mea e ka rava te aronga ‘anga‘anga e ka



rauka mai te meitaki e mānganui, ko te moni tauturu i reira ta te Kavamani i oronga ki roto i te tu'anga 'apinga 'anga'anga ka riro ei meitaki no te tuātau 'akamātū.

I 'akaputu ana te CIG i roto i te 'apinga 'anga'anga no tēta'i nga'uru mataiti inara i te mea oki e, e tu'anga enua kimi pū'apinga meangiti ua to tātou e tei irinaki ma'ata ki runga i te tu'anga tūroto e ma'ata i reira te "akaputu'anga 'apinga 'anga'anga te ka anoano'ia no te tauturu i te Bāsileia mei tei 'akakite'ia ki roto i te NIIP.

Ko te 'iki'anga i te 'anga'anga mama'ata tau ka akatupu te reira i te ngai 'anga'anga tuātau poto te ka tā'anga'anga i te iti tangata Kūki 'Airani e te mou katoa i to tātou nūmero tangata, e ka akaoki katoa mai i to tātou iti tangata mei vao mai ki te ipukarea me kare ka akameitaki atu i te tu'anga 'anga'anga na roto i te apai'anga mai anga i te aronga 'anga'anga pōrena. Ko teia au 'anga'anga mama'ata e te aronga 'anga'anga ka oko ratou i te au 'apinga no ko i te au pītiniti Kūki 'Airani te ka riro ei meitaki no te katoatoa.

I te pū'apinga e toto'a ra, e tikaanga manea katoa teia no te au pītiniti i te atui ki roto i te mākete, e ka ma'ata atu te au ngai 'anga'anga ka rauka mai, e ka riro ei meitaki no tēta'i au pītiniti kekē e pera te iti tangata.

Kua riro te tamanamanata ta te Kōviti 19 i akatupu i te tu'anga kimi pū'apinga i te akaiti i te moni ko'i a te Kavamani, tei riro i te 'akatūkia i te tu'anga moni tei akakoro'ia ei 'akaputu no te 'apinga 'anga'anga, no runga i te au tumu tei tāiku'ia i runga nei, e mea pū'apinga kia raveia atu rai teia au "akaputu'anga.

Kua aiteite katoa te ara-'anga'anga a te ERR, e 'ākara nei i te tumu e iti nei te nūmero tangata, 'ē i runga atu i teia i te akama'ata aka'ōu i te nūmero tangata. Ko te tu'anga 'anga'anga e te porokarāmu numero tangata kare te reira e riro ana i te rapakau i te numero tangata i roto i te tu'anga 'akatū are, inara e 'ātuituianga tēta'i ka rauka mai no roto i teia au porokarāmu. Mē kā tika, 'ākara ki te tātāanga porokarāmu ERR no runga i te aronga 'anga'anga e te tārē tangata me ka anoano mārama koe no runga i teia tāpura.

Te Kōtinga o te Moni e te Aronga 'anga'anga - Fiscal and Labour Limitations

I teia nei te 'anga'anga nei te CIG i raro ake i tēta'i tu'anga moni ko'i 'akaiti'ia no te 'akatūkia'anga ta te maki Kōviti i 'akatupu, e kua irinakiia e ka oki mai teia moni ko'i a teia au mataiti ki mua, ko te 'akatano'anga i ta tātou kaio'u ka kake ma'ata te reira i te toenga o teia nga'uru mataiti e tū mai nei me aruia te tāmanako'anga o teia tuātau. Ka riro teia i te arataki i te Kavamani kia tā'anga'anga matakite i te moni i teia tuātau pāpūkore. Mē kā tika 'ākara ki te tātāanga porokarāmu ERR no runga i te 'akatere'anga i te Kaio'u a te katoatoa me ka anoano mārama koe no runga i teia tāpura

E iti ua te aronga 'anga'anga i roto nei i te Kuki Airani e mei te reira katoa i mua ake ka tupu ei teia maki rikarika e kua akatūkia te reira i to tātou tūranga no te akakeu i te au 'apinga 'anga'anga mama'ata. Kua kino atu to tātou no te aronga 'anga'anga maroiroi tei 'akaruke atu i teia tuātau moni kore. Ko tei tupu, kāre e rava ana te aronga 'anga'anga e te au pākau 'anga'anga te ka piri atu ki roto i te 'akaputu'anga 'apinga 'anga'anga, e ko tona aiteanga e iti ua te au 'anga'anga mamata ka rauka i te rave e te tūtaki e auraka katoa e akateimaa i te tu'anga 'akatū.

Me kāpitī'ia te 'akakōtinga'anga moni e te aronga 'anga'anga ka 'akakeu te reira i te parāni matakite o te 'apinga 'anga'anga te ka 'akatinamou ki runga i te 'akatūkia o te tu'anga 'anga'anga

poto e te meitaki no roto i te tu'anga kimi pū'apinga e te moni te ka oki mai ki roto i te pūtē moni tei 'akaputua. I te mea oki e te anoanoia nei te moni kaio'u e te moni tauturu no vao mai ei tauturu i te 'akapou'anga 'akatere a te Kavamani e pera te 'akaputu'anga 'apinga 'anga'anga, ko te tāmanako'anga no te tūtaki'anga i te meitaki o teia au 'anga'anga mama'ata ka 'inangaro'ia kia taka meitaki te 'akakoro'anga o te "akaputu'anga.

Kapiti katoa atu i te reira, ko te moni kaio'u, te moni tauturu nō vao mai ka anoano'ia kia āru'ia te au taka'i'anga e 'akatika'ia ai e te kopapa oronga me kare te tangata oronga, e pakari te ture no te 'akatika'anga e te au taka'i'anga no te rīpōti'anga me kare te akakōtinga'anga ki te runga i te tā'anga'angaanga o te moni tauturu. No teia , ka 'inangaro'ia te porokarāmu 'akaputu no te 'apinga 'anga'anga kia akatanotano meitakiia no te tā'anga'anga i te moni a te CIG e te moni tauturu (me kare te moni kaiou) nō va'o mai

Te 'Anga'anga - Project

Ko te ara-angaanga o te 'akaputu'anga no te 'apinga 'anga'anga i roto i te aranui akamātūtū kimi pū'apinga kare te reira i te tu'anga 'anga'anga 'okota'i. E kaveinga ma'ata a ia ki roto 'akatu'a'angā moni a te Kavamani no te 'akaputu'anga 'apinga 'anga'anga no te au tu'anga 'anga'anga mama'ata tei tau ki raro ake i te 'akapapa'anga i runga nei, e pera katoa i te akakeu'anga kia ma'ata te au ngai 'anga'anga ma te kore e tāmanamanatā i te i te aronga 'anga'anga e 'anga'anga nei.

Ko te 'āite'anga o te tūkaui i roto i te tūranga aronga 'anga'anga koia oki me rave'ia tēta'i au 'anga'anga mama'ata i te taime 'okota'i, kare te reira i te mea tau, no reira ka 'inangaro'ia kia kā'iro'ia te 'anga'anga mama'ata e te au mea rikiriki. Ko te taka'inga mua koia oki ko te 'ākara'anga i te au 'anga'anga mama'ata a te NIIP kia rauka i te kite e ko tē'ea te ka 'ōronga mai i te meitaki poto e te tūpoto e te au tāmanako'anga. Ko te au 'anga'anga mama'ata, ara atu i te (10mirioni) ka 'ākara mataio'ia te reira, mei te ngā'i vairanga repo tangata, te au 'ana e te akamanea anga i te taoni i Avarua,

Ko teia tēta'i au tu'anga 'anga'anga mama'ata i tamanakoia:

1. Mei te Vai Ki te Vai (Te akameitakianga i te ngai vairanga repo i Muri)
2. Vaikapuangi (Ngutuare Kavamani)

Ka akatupu teia tu'anga 'anga'anga mama'ata i tēta'i au ngai 'anga'anga e mānganui e, e pū'apinga poto e te tūpoto to rāua, inārā e āka 'akapu'anga to runga i teia nga 'anga'anga(ara atu i te 50 mirioni) te ka aru i te au taka'i'anga akatū ngatā e te parāni mātūtū.

Ko te au akatikatikaanga no te tūtakianga i te 'akaputu'anga 'apinga 'anga'anga ka na roto mai te reira i te 'Akano'o'anga Tarai Vaka a te Kavamani, e ko te moni tauturu ka rauka mai na roto i te kaio'u me kare te tu'anga moni tauturu mei te Kopapa moni 'akaputu no te 'apinga 'anga'anga ko te akatikaanga takakē e te akatereanga i te 'anga'anga na te putuputuanga 'ōronga me kare te tangata oronga te reira e pati.

'Ātuitui'anga - Engagement

Ko teia 'anga'anga ka akatereia te reira e tēta'i au tu'anga o te Kavamani koia ko te :

1. Te Mato Vairanga Mou o te Kūki 'Airani e te Kūmiti 'Akapū'apinga
2. Te Tango 'Anga'anga

3. Te Tango ‘Akatere‘anga Moni o te Ipukarea

Kua na roto te NIIP i tēta‘i ‘uri‘uri‘anga manako pakari ki te iti tangata no te te‘ate‘amamao i te kaveanga karere meitaki ki te au tu‘anga parāni ‘akatū o te Kuki Airani.

Ka ‘anga‘anga kapiti uātu rai te Kavamani ki te Te Manatu o Tawahi o Aotearo‘a na roto i te Kūmitiona Ngāteitei o Aotearo‘a i te Kuki Airani nei no te tu‘anga moni tauturu na roto i te Kōpapa moni Tauturu i te Tu‘anga Akatū.

Te Akapou‘anga - Estimated Cost

Ko te ‘akapou‘anga ka āru‘ia te reira nā runga i te ‘akataka‘anga o te ‘anga‘anga te ka raveia i te tuātau ‘ākarakaraanga e pērā te akatikaanga. Ka rīpōti‘ia teia na roto i te tāmanako‘anga ‘akapapa‘anga moni ki roto i te ‘Akapapa‘anga ‘Akapou‘anga me kare te ‘Akapapa‘anga Akapū‘apinga Tau.
