



‘Akatere‘anga i te kaio‘u a te kātoatoa – ‘Akakaio‘u‘anga e te Moni Tauturu

‘Akakaio‘u‘anga - Overview

Kua ‘anga‘anga kāpiti ana te Kavamani Kūki ‘Airani ki te ADB i te akatinamou i tetai tuanga moni tauturu i te Kavamani nā roto i te tūranga Kaio‘u ‘Akatango Kaveinga (PBL) e \$40 mirioni moni Marike e pērā te Tūranga Moni Te‘ate‘a (PFO) mei tetai \$40 mirioni moni Marike, mē ‘ē uake ē e au tuanga tetai ka anoano‘ia kia rave‘ia e ka ‘inangaro‘ia te moni. Ko teia ngā kaio‘u nei kua taui te reira ki roto i te moni Aotearo‘a e kua rauka mai \$55.4 mirioni i te kaio‘u ‘okotai e ko te roa o te tuātau tūtaki e 15 mataiti te reira.

Ko te ADB tētai pātana piri vaitata ki te tūranga ‘akapū‘apinga o te Kūki ‘Airani e ko ia te tauturu maata o te Kavamani Kuki Airani. E ma‘ata te au Bāsileia i roto i tēia putuputu‘anga, e ko te ADB e 68 au mema e ‘ona kapipiti ana(ko te Kūki ‘Airani tēta‘i ‘ona), e ko tetai 49 ‘ona no roto teia i te pa enua Atia-Patipika. E tūpae ana te ADB i tona au mema e te au pātana na roto i te ‘ōronga‘anga kaio‘u, tauturu i te ngai tei anoano‘ia kia ‘akameitaki‘ia, moni tauturu i te au porokarāmu ‘akapū‘apinga e te moni ‘akaputu a te Kamupani no te ‘akamārua i te akameitaki atu i te tūranga tangata e pērā te tu‘anga kimi pū‘apinga. Kaio‘u ‘Akatango Kaveinga - Policy-Based Loan

No te tu‘anga tūtaki‘anga i te PBL, kua ‘anga‘anga kāpiti ana te Kūki ‘Airani ki te ADB no te kimi e te rave i tetai au akatūkē‘anga ki te au kaveinga pū‘apinga no te tauturu i te tuanga kimi pū‘apinga kia maranga ‘aka‘ōu te tūranga no roto mai i te Kōviti – 19. Ko teia au ‘akatūkē‘anga kua ‘akatinamou‘ia ki runga i teia ngā tu‘anga:

Tu‘anga ‘Akatūkē‘anga 1 – ‘Akaterē‘anga Moni e te Tūranga Mātūtū: Ka turu tēia porokarāmu i te ‘akatika‘anga e te tā‘anga‘anga‘anga i te Kura o te Moni Tuātau Tūpoto tei akatūkē‘ia no te FY2022 – FY2025. Kua tā‘anga‘anga takere‘ia tēia ‘akatūkē‘anga Rāvenga Moni Tūpoto 2022/23 e kua nene‘i‘ia i te ‘āpa mata‘iti 2021/22 o te Tu‘anga Kimi pū‘apinga e te ‘Akakite‘anga moni (HYEFU).

Tu‘anga ‘Akatūkē‘anga 2 – “Akatūia‘anga i te tūranga no te au tuanga kimi pū‘apinga kare i raro ake i te Kavamani: Ko tēia porokarāmu ka turu te reira i te tā‘anga‘anga‘anga o tētai au



vāito'anga matatio no te tango e te rave 'uātu rai i te Teretere'anga Rāui-Kore'ia mei Aotearo'a mai, e te 'ākara i te au tuanga pū'apinga no te 'akameitaki i te tūranga 'anga'anga, mei te tikaanga o te neke'anga i te aronga 'anga'anga e te akaiti i te 'akapou'anga no te 'akamata i tetāi pītiniti. Ko teia au vāito'anga nei, kua tā'anga'anga takere'ia me kare e tu'anga ratou ki roto i te porokarāmu 'anga'anga o te Aranui 'Akamatūtū i te Kimi Pū'apinga.

Ko tētai au akatūkēanga kua rauka takere te reira i roto i te tuanga mei te rētitā'anga pītiniti e te au 'akataka'anga o te 'emo'anga.

Ko te NZ\$55.4 mirioni no te PBL kua kiriti'ia mai te reira i roto 'ia Tītema i te mataiti 2021.

Tūranga Moni Te'ate'a

Ko te PFO e kaio'u 'akakena'ia teia, e ka āru'ia tetai au takainga i mua ake ka rauka ai i te kiriti i te reira – e ka 'ātui teia ki te tōpiri'anga kena Bāsileia e pērā te ngere o te tūroto.

Kare te Kavamani e umuumu ana i te tā'anga'anga i teia tu'angā moni nō te ma'ata o te takainga e rauka ai te kaio'u, ināra me inangaro'ia ka rauka i te kiriti mai mei \$55 mirioni moni Aotearo'a no te tūtaki i tēia tu'anga 'anga'anga.

Tauturu'anga i te Manamanatā Rikarika

Kapiti katoa atu ki teia tuanga nei e 'akatika'anga 'akakaio'u'anga tetai i te'ate'amamao'ia i rotopu i te Kavamani e te ADB mei te \$30.3 mirioni moni Aotearo'a e kaio'u 'akakena'ia te ka rauka i te tā'anga'anga me tupu ake tetai manamanatā rikarika mei te uri'ia. Tei roto tēia i te taka'inga 3 o te Porokarāmu Akamatūtū Manamanatā Rikarika a te ADB.

Te Kātoatoa o te Kaio'u Kōviti 19

Me te tuātau mai i akamata ai teia maki rikarika, e ma'ata te au kaio'u ta te Kavamani Kūki 'Airani i tāruna na runga ake i te au kaio'u e vai nei. Ko te ma'ata o te kaio'u, e te au akakaio'uanga tātakita'i e te tuātau no te tūtaki'anga kua akaaria atu te reira ki roto i te Akapapaanga 1. Ko te katoaanga o te kaio'u tei kiritia mai no te maki Kōviti 19 e \$129.1 mirioni te reira, kapiti kātoa mai te \$55.4 mirioni ei kaio'u 'akakena'ia(PFO). Me kapitiia mai te akakaio'uanga o te Porokarāmu 'Akamatūtū mei te Manamanatā Rikarika ko te katoa'anga e \$85.8 mirioni te ka rauka i te tā'anga'anga.



Te au Ture ‘Akakōtinga Ta‘anga‘anga Moni e te No‘oranga Kaio‘u a te Kavamani

Na roto i te Kura Tā‘anga‘anga moni tūpoto(MTFF) e ma‘ata te au ture a te kavamani e āru ana i te akapāpū e kia kauraroia te au ‘akakōtinga.anga. Ko te au ture tei ‘ātui ki te kaio‘u ko te Ture ‘Akaputu, e te Ture no te Katoa‘anga o te Kaio‘u. Ka ‘anga‘anga kāpiti teia au ture nei no te ‘akapāpū i te Kavamani e ko teta‘i ‘uātu tāra‘u‘anga i runga ake i te 55 patene o te ārai Pū‘apinga Basileia ka koro‘ia te reira ki te ‘akaputu‘anga ‘oko ‘enua e te ‘are e pera te pū‘apinga Bāsileia tei ‘akakoro‘ia.




Akatanotanoanga Kaio‘u

Ko te akatanotanoanga kaio‘u ko te tūtaki‘anga te reira i te kaio‘u – ko te kōpapa moni e te moni ‘akauta. No te maata o te ‘akakaio‘u‘anga i raveia i te tuātau o te maki rikarika, ko te kopapa moni kua tupu te reira ki te maata – tei riro i te ‘aka‘aere i te akatanotanoanga kaio‘u kia maata atu i te akanooanga i te openga o te nga‘uru mataitī(‘ākara i te tūtū 2). Tei roto katoa i te MTFF te akanooanga no runga i te akatanotanoanga kaio‘u, e ko te kaveinga maata kia noo ua rai te vā iti i raro ake i te 10 patene o te katoaanga o te moni ko‘i a te kavamani e te vā maata e 15 patene.

Te Moni Tauturu. Aid Funding

Mei tei mataua ko te moni ‘Tauturu Akapū’apinga tei Akamanaia’ tei roto i reira te akaueanga o te tauturu na roto i te moni me kare te au apinga ‘anga’anga e te ravenga tauturu. Ko te tauturu moni ka orongaia te reira na roto i te moni tauturu tei atuia ki tetai tuanga ‘anga’anga, me kāre te akapapaanga moni a te katoatoa te akatu‘angaia e e moni ko‘i na te Kavamani.

Ko te tuanga moni tauturu e au akakōtinga‘anga e te takaianga tetai no runga i te ta‘anga‘angaanga o te reira tuanga moni, te au akatakaanga ripoti no te ta‘anga‘angaanga i te reira tuanga moni, me kare tetai tauianga no te kaveinga a te Kavamani. I tetai au taime ka akatere kapitia teia tuanga moni, mei te tuanga moni tei orongaia ki te Kavamani e te NZ-MFAT tei na roto mai i te Putē moni Akameitaki, me kare te ka ta‘anga‘angaia i raro ake i te tika a te Kavamani i roto ra i te koro tei akanooia i te kopapa oronga.

E maata te tuanga moni tauturu ta te NZ-MFAT e ‘ōronga mai ana ki te Kavamani mei te tuātau i akamata ai te Maiki Kōviti no te tauturu i te Parāni Akamātūtū Kimi Pū‘apinga e te Aranui ‘Akamātūtū Kimi Pū‘apinga, e te tā‘anga‘anga i te vairākau e te pāruru‘anga i te kena Bāsileia, e te apai mai anga i te vairakau Kōviti 19. Kua riro teia tauturu i te akaiti maata i te au takaianga moni kaio‘u a te Kūki ‘Airani e tetai au tuanga ‘anga’anga i roto tikai i te rīpōtianga i te tā‘anga‘anga‘anga o teia tuanga moni tauturu.

Kua rauka katoa mai tetai tauturu maata mei tetai au Kavamani ke e pera te MLI mei te au apinga ‘anga’anga e te tauturu i te akapapaanga moni. Kua akatakaia teia tauturu ki roto i te akapapaanga moni tāmanako e te Tuanga Kimi pū‘apinga e te ‘Akakite‘anga moni(HYEFU).
