Ko te 'akakoro'anga i tēia porokarāmu koia oki ko te 'ākara'anga i te rāvenga kaveinga no te 'akaketaketa e te 'akameitaki i te rave'anga 'anga'anga, te au 'akapapa'anga o te Tu'anga 'anga'anga Kavamani na roto i te 'anga'anga kāpiti'anga ki rotopū i te au 'ātava-tumu o te Kavamani kia rauka i te 'akatupu i te 'inangaro o te aronga 'oko'oko e te aronga 'anga'anga kia tau te tūtaki.

Te kimi nei te Kavamani i tēta'i au ta'unga kite karape no te 'ākara meitaki i te 'akano'o'anga o te kavamani i te kimi'anga i te au ngā'i 'ē tūkatikati ra e pērā te au tu'anga 'anga'anga 'āiteite e te rāvenga 'anga'anga kia rauka i te 'anga i tēta'i 'ākara'anga meitaki atu mate 'akamātūtū atu i te au tu'anga 'anga'anga. Ko tēta'i au pū'apinga takakē atu mei te 'akapou'anga māmā na roto i te 'akano'o'anga meitaki atu, noātu rā te reira kāre e ko tēia te kaveinga tumu 'ō tēia 'ākarakara 'aka'ōu'anga.

Ko te tūtaki'anga o tēia porokarāmu mei roto mai te reira i te au pātana tūtaki o te Kūki 'Airani noātu ra te reira kua 'ātui'ia tēia 'anga'anga ki roto i te Aranui 'akamātūtū i te Kimi Pū'apinga (ERR).

Te Ata - Context

Kāre te 'akatere'anga a te Kavamani Kūki 'Airani i taui ma'ata ana mei te taui'anga manakokore'ia i te mataiti 1995, kua tupu mārie te tu'anga 'anga'anga e te rāvenga 'anga'anga tei 'akatupu i te au tu'anga 'anga'anga tūkētūkē ki roto tikai i te au Tipātimani o te Kavamani ('ātava-tumu)

Ko te au 'akapapa'anga o te Tango 'Akatera o te Kavamani kua 'akaari'ia te reira i roto i te pi'a 'akaari numero 1.

Ko te Paepae Ropi'anga tei raro ake te reira i te 'akatere'anga a te Kavamani(tei matauia e ko te Kōpapa 'akatika) e i te au Māraurau 'ē rīpōti ra ki te Kūmitiona o te Paepae Ropi'anga e te Minita, ko e au 'ātava-tumu tei 'akamana'ia ka rīpōti rātou ki tēta'i 'āponga e ki te Minita. Ko te au Kavamani Enua e 10 ka rīpōti rātou ki te au Mata o te Kavamani, te au Konitara e te Tama 'Akatera o te Koutu Mana Tutara o te Bāsileia.

Ko te tu'anga ropi'anga ora'anga te to'u nei te reira ki te au 'Ātava-tumu o te Korōna te ka rīpōti tika ki te Pāramani, te 'Ōpati tauturu o te Minita e te 'Are Ariki. Tei roto i te tu'anga ropi'anga



ora‘anga te au ngā‘i ‘anga‘anga tukēkē tei ‘akatere‘ia e te kavamani na roto i te Mato Vairanga Mou o te Kūki ‘Airani.

E mea pū‘apinga ma‘ata no te kavamani kia ‘ākara ki te au taui‘anga anoano o te matakeinanga, e me ‘apai‘ia mai tēta‘i kōpapa mā‘ani ture ‘ōu, te kaveinga tumu me kāre te au rāvenga ‘anga‘anga e tupu ana te tūkatikati‘anga ki roto i te ‘akatua‘anga‘anga i te au ‘anga‘angaa i rotopū i te au ‘ātava-tumu tūkētūkē te ka ‘akatupu i te tūkaui i roto i te ‘ōronga‘anga ropi‘anga ora‘anga ki te ‘iti tangata.

Ko te ‘akano‘o‘anga tūkaui i roto i te kavamani ka ‘akatupu te reira i tēta‘i au tuku‘angā tika taukore tā kā riro ei ‘apainga teima‘a i te ta‘anga‘anga e te ‘akatano i tēta‘i au ropi‘anga ora‘anga tūkēkē. Ka riro tēia i te ‘arapaki i te tu‘anga kimi pū‘apinga nā roto i te tupu‘anga mārie me kāre te ‘akaneke‘anga o tēta‘i au tika‘anga ‘ōu ki tēta‘i au tuku‘angā tika takakē te ka māmā ua i te ‘akatano.

E mea tau kia ‘ākara putuputu‘ia te ‘akano‘o‘anga o te Kavamani kia rauka i te ‘akapāpū e ko tēia au ‘akapapa‘anga tūkaui kia ‘akaiti‘ia e kia rauka i te Kavamani i te tauturu i tōna au mangamanga ‘akapū‘apinga, e pērā te au pītiniti kāre i raro ake i te kavamani.

Te Angaanga - Project

Ko te ‘akakoro‘anga ma‘ata o teia ‘anga‘anga koia ko te ‘akamātūtū i te tūranga e te meitaki o te tauturu te ka ‘ōronga‘ia ki te Ropi‘anga Iti-tangata na roto i te:

1. ‘Ākara ‘aka‘ōu‘anga ki roto i te Tūranga o te Ropi‘anga Iti-Tangata te ka ‘akatere‘ia e tēta‘i Ta‘unga Kite-pakari no va‘o mai.
2. E parāni tiēni‘anga i te ‘akatere‘anga tei tātuātau‘ia – akamanako‘anga i tēta‘i kura ‘akakou i te au tu‘anga rikiriki i roto i te Kavamani, ‘akatanotano‘anga e te au taka‘i‘anga o te ropi‘anga ‘iti tangata kia rauka i te ‘akatano i te au ‘akatere‘anga e te au taka‘inga kia tau ki te taui‘anga o te ao kimi pū‘apinga e kia au katoa ki te Ara ‘akapapa‘anga Nui, e Te Rāvenga Akapū‘apinga i te Tu‘anga Kimi Pū‘apinga e te EER

Ka rave te Tūranga o te Ropi‘anga i te iti tangata i tēia:

- a) “Akataka i te ‘akano‘ono‘o‘anga a te ‘ōrau: ‘ākara matatio i te kura kōpapa mā‘ani ture mei te ture iti o te ‘akatere‘anga i te tu‘anga ‘anga‘anga o te au Māraurau tūkēkē kia rauka i te ‘ākara i to rātou ‘ātuitui‘anga, ē mē kua tau rātou ki te ‘akakoro‘anga.

- b) 'Akataka i te tū o te putuputu'anga e te 'akano'o'anga: 'ākara matatio i te 'akano'o'anga pātū e te takoto, no te 'akapāpūanga e me te turu nei tēia i te au rāvenga 'anga'anga e te tika'anga 'anga'anga i te au 'ati'anga ravarāi.
- c) 'Akataka i te au tu'anga 'anga'anga tei 'ōronga'ia: 'ākara matatio i te au tu'anga 'anga'anga tūkētūkē no te 'akapāpū i to rātou 'ātui'anga. Pēnei ka piri mai te 'iki'anga i te 'anga'anga tātākita'i ta te au Māraurau e rave ana e tōna 'ātui'anga ki ta rātou au 'akaue'anga.
- d) 'Ākara matatio i te ma'ata o te tu'anga no te ruru'anga i te au tauturu e tīkotikoti ra, mei te 'akatere'anga i te aronga 'anga'anga, ko'i'anga, 'akaputu'anga e te tuku'anga kārere uira e te 'aka'aere'anga kia rauka i te 'iti tangata Kūki 'Airani i te 'akaotī i tā rātou tukuanga kārere uira ki te Kavamani.
- e) 'Ākara matatioanga 'ē mē kua tau rai te Tu'anga 'anga'anga Tātakita'i ki raro ake i te Kavamani kia kāpitīia ki te nga'i 'okota'i kia rauka i te rōtai mai i te au tauturu 'ē tīkotikotī ra, mei te 'akaroa'anga i te 'akapapa'anga tūtaki'anga moni a te Kavamani no te tāmaru i te SOE. Kia tamanako'ia mai tēta'i Ropī'anga Ipukarea mei ta Aotero'a rai i te 'ātui'anga mai i te SOE ei tūranga ma'ata no tēia tāmanako'anga.
- f) Kaveing Tau no te 'akatere'anga Ropī'anga Ipukarea mā'ora'ora.

Ko te parāni tiēni'anga i te 'akatere'anga tei tātuātau'ia, mate 'ākara katoa i te tūkaiu ki roto i te tūranga o te moni, ka te'ate'amamao te reira au tāmanako'anga i te ta'anga'anga i te parāni no te tupu'anga tau ua me kāre 'akakake'anga i te au tāmanako'anga te ka 'iki'ia mai e te tu'anga Akara 'aka'ōu'anga i te Rāvenga 'anga'anga no te Ropī'anga iti tangata.

'Ātuitui'anga - Engagement

Ka akatereia tēia tu'anga 'anga'anga e te Paepae ropī'anga o te Kavamani e pērā te tauturu a te Tango 'akatere'anga moni o te Ipukarea. Ka riro e na te Pupu 'Akaterē e tāmarumaru i tēia 'ākara 'aka'ōu'anga e ko tēia te au 'Akaterē o te au 'ātava-tumu to roto i tēia pupu, Kūmitiona o te Tango Ropī'anga, Tēkererē o te moni, Tiānara 'Akavā-nui e te 'Akaterē 'anga'anga.

Kāre e 'ātuitui'anga manako ki te iti tangata, inara te 'ākara'ia atu nei tēta'i 'uri'uri'anga ki te au putuputu'anga kāre i raro ake i te Kavamani(NGO) e nā te tama 'akatere e tāmanako mai e mē otī mai, ka akakiteia atu rai ki te katoatoa.
